BOOKINGS OF AIR FORCE FUND HOLIDAY ACCOMMODATION - 2012

1. Bookings of Air Force Fund Holiday Flats, syndication weeks and timeshare weeks will open on 3 October 2011 for 2012. The RCI calendar for 2012 will be used for future bookings at SAAF Fund holiday flats which means holidays will start on a Friday and end on a Friday or Friday to Monday (weekend) or Monday to Friday (midweek).
2. Bookings for the four main School holidays (high peak season) must be done by completing the prescribed application form. The application form must be handed in, posted or faxed to the Air force Fund office between 03 October 11 and 31 October 11. Bookings for non holiday periods (low season) may be made personally or by telephoning 012 312 2281 throughout the year with effect from 03 October 2011.
3. Bookings for Kruger Park Lodge (KPL), Castleburn and the Timeshare weeks are done in the same way as described in para 2 above. Only High Peak Season (HPS) must be applied for by using the prescribed application form.
4. A pro forma application form for the reservation of a holiday flat is attached. Addressees are requested to hand copies of the application form to members on request. Prospective applicants must take cognizance of the rules pertaining to the occupation of the flats as set out in paragraphs 1 to 9 of the application form.
5. On 03 October 2011 only two telephone lines will be available for assisting members who wish to book on that day. Telephone numbers are : 012 312 2281/2354.
6. Members are encouraged to respond to this notice and if they do, their chances are good to be allocated accommodation at the venue of their choice. The rates for 2011 are attached. The cost of owning holiday flats have increased dramatically. The following increases have been recorded – Levies 8% - 15%, electricity and water 20% - 30% and in some cases more. Even with these increases SAAF Fund holiday accommodation is still 30% - 40% lower than the same flat size being let by letting agencies along coastal regions.
7. It is requested that the contents of this letter is brought to the attention of all Air Force Fund members.
